On 23/08/2023 at @ 8:00 pm, while I was purchased some eatable items from one of the shop after parking my Honda Dio B/Regn. No. MN05E1106, Engine No. JF39ET4043579, Chassis No. ME4JF39HFJT028620, V Orange in colour, 2018 model with proper locked in front of the Abok Ki Ngamok Hotel, Thoubal Okram heard a sound as "GARI HURANKHRE" "GARI HURANKHRE". Immediately, I checked for my vehicle and found to have been stolen by some unknown persons. On the same day at @ 8:10 pm one of the my friend informed me that two unknown persons suspected to be vehicle lifters were caught red handed along with the stolen vehicle at Thoubal Okram Lamkhai Sorok Wangma. Without delay, I went to the said place and checked the vehicle and found out to be my vehicle Honda DIO B/Regn. No. MN05E1106. On asking the two individuals they identified themselves as (1) Bm. Aziz Hasmi (19) yrs S/o. (L) Md. Liyakat Ali of Lilong Hangamthabi, PS- Lilong, Dist- Thoubal, Manipur (2) Arish Khan (20) yrs S/o Md. Kayamuddin @ Ali of Lilong Ubakthong. They came riding one Honda Activa B/Regn. No. MN01AN0657. Further, they disclosed that the Honda Dio B/Regn. No. MN05E1106 had stolen by them.

As so, the two individual along with 2 (two) nos. of two wheeler vehicles i.e. (1) which was stolen by them (belonging to me) and (2) the another two wheeler which they came riding mentioned above are handed over to you for further legal action.
