No. NIL ridden by an unknown rider coming from Thoubal side towards Wangjing side dashed one unknown male cyclist along NH 102 near Sorojini Oil Pump, Khangabok due to rash or negligent riding on the part of the unknown rider of Honda Activa B/Regn. NIL. As a result of which the unknown male cyclist and unknown rider of Honda Activa had received injuries on their persons. While the nearby local people were trying to evacuate the injured persons to Hospital one Bajaj Pulsar B/Regn. No. MN06SA1012 ridden by an unknown rider which was coming from Thoubal side towards Wangjing side dashed to the back side of one parked Mahindra THAR B/Regn. No. NIL which was stopped by the local peoples for evacuating the injured persons due to rash or negligent riding on the part of the unknown rider of Bajaj Pulsar. As a result of which the unknown rider of the Bajaj Pulsar received injury on his person. All the injured persons were evacuated to Hospital by the local peoples. The Honda Activa B/Regn. No. NIL, Bajaj Pulsar B/Regn. No. MN06SA1012 & Mahindra THAR were partly damaged.

Hence, a sou-motu case under FIR No. 159(8)2023 TBL-PS u/s 279/338/427 IPC has been registered for investigation.
