Subject: Request for intervention and necessary direction to the Officer-in-Charge, Thoubal Police Station as the same has failed to entertain my complaint / register F.I.R. on the undernoted matter.

Sir,

I, the undersigned went to the office of O.C. Thoubal Police Station to lodge a complaint on two occasions i.e. on 20/08/2023 and 21/08/2023. Whereas, the concerned officials of the said Police Station have failed to accept my complaint and denied my humble request to lodge F.I.R.

For your kind perusal the contents of the said complaint are reproduced as hereunder:

*"With due respect the undersigned hereby would like to state that, on 2<sup>nd</sup> May 2023 an unfortunate incident occurred at my residence at Wangjing Heitupokpi Awang Leikai Soibam Leirak around 9 A.M. as some persons around 15 in numbers having a deliberate conspiracy trespassed into my resident taking the opportunity of no family members at the house and dismantled/demolished my house, henhouse, hog house using tractor and deadly weapon. Thereafter they looted jewellery, grain from granary and other goods collectively worth about 40 lakhs resulting from our lifelong earnings and savings which were wiped off. That the said incidents took place in the broad daylight witnessed by the locality. It has been learnt that the said criminal acts were committed led by the following persons namely:*

1. Soibam Jaininikanta Singh, aged about 50 yrs, S/o. S. Sudan Singh a resident of Wangjing Heitupokpi.
2. Soibam Ashokumar Singh, aged about 48 yrs, S/o. S. Sudan Singh, a resident of Wangjing Heitupokpi.
3. Soibam Salen Singh, aged about 60 yrs, S/o. (i.) S. Tompok Singh, a resident of Wangjing Heitupokpi.

4. Soibam Sarat Singh, aged about 55 yrs, S/o (L) S. Fulla Singh, a resident of Wangjing Heitupokpi,
5. Soibam Rajen Singh aged about 65 years, S/O (L) Soibam Mangi Singh of Wangjing Heitupokpi

These incidents left my entire family members into mental shock and the same is still lingering. My family members are also being displaced and severely affected our livelihood.

After the incident has happened my daughter Soibam Roshni Devi was wilfully assaulted using criminal force in front of the localities called out by banging the electric pole with an intention to outrage her modesty as well as threaten her to face the consequences if she is further seen in the locality by one Shoibam Thaba, w/o Shoibam Ashokumar. While such violent criminal act was occurring one Soibam Nepolean Singh, S/O Soibam Jaminikanta snatched my daughter's mobile phone being one MI Note 13 Prime grey in colour using criminal force and possessed by him. My said daughter was also beaten in the face and ear and she had to take medicines for a week to relieve the pain. After the incident my family members could not enter our own home and lands as threat and intimidation being posed by the perpetrators.

That due to the mental shock and petrification caused by the incident, fear of being attack as well as due to the present crisis in the State due to communal riot I couldn't lodge complaint on a reasonable period. And also due to the lack of legal knowledge about the same there is a delay in lodging this complaint.

Therefore, the undersigned would like to urge you to entertain this complaint, book / arrest the perpetrators, recover our stolen goods, compensate for the loss and look after the provision of better security for my family members to resettle at our home.

Your kindness of prompt action will be appreciated and would remain obliged."

It is humbly put to the knowledge of your good office that, my family has been living in a very harsh situation since the unfortunate incident took place in the 2<sup>nd</sup> May, 2023. We are not able to enter and resettle at our own home due to threats and the same have adversely affected our livelihood.

Therefore, your good office is requested to intervene in the said matter and pass any proper direction to the concerned of the Thoubal Police Station to take up immediate and necessary action.
