



Sir,

I am to report that today i.e. 2/9/2023 at about 7 am, some unknown persons coming in some four wheeler vehicles including one grey colour Hyundai Creta registration no. not known had entered inside my house holding small arms. They ransacked my house and looted all valuable items including Rs. 8,00,000 (eight lakh) (approx.) in cash, jewelery items worth Rs. 97,50,000 (ninety seven lakh fifty thousand) (approx.), two mobile handsets, one SBBL licence gun with its licence and other itmes from inside the house after I along with my wife were putting in fear of death using their guns. Further they fled away towards unknown direction in their vehicles after commission of the offence at about 7:30 am. Details of looted items will be furnished shortly.

It is therefore, requested to kindly take up necessary legal action as per law.
