

Subject:- Report

Sir,

I have the honour to report that on 03/09/2023 at about 11.00 pm I along with my team conducted frisking and checking of suspected vehicles in order to detect movement of anti social elements with armed under the supervision of Superintendent of Police, Thoubal at Khangabok Mayai Leikai. While conducting frisking and checking, one unknown vehicle was seen proceeding from Thoubal side towards Khangabok in a suspicious manner. On seeing the police team, the unknown person took a U-turn and tried to flee away. Immediately, the police team pursued the fleeing vehicle. Some local people who were beside the road also assisted the police team. The vehicle was stopped in front of Trio Development Club, Khangabok and detained for verification on 04/09/2023 at about 1.00 am. I identified myself as police officer and my team also police personnel of CDO/ TBL. Then, I asked the identity of the detainee in presence of the witnesses. In that he identified himself as Md. Fajur Rahaman (48) S/O (L) Md. Sanamanik of Sangaiyumpham Part II Cherapur Makha Leikai. On searching the vehicle Santro with local people, the police team detected two sack (bag) containing 204/(two hundred and four) nos of bottle marked as Codeine Phosphate & Triprolidine Hydrochloride Syrup of 100 ml capacity. Accordingly, I informed W. Ibocha Singh, MPS, SDPO/TBL to be witness during searching the above vehicle and body of the individual. In the meantime, the above Santro vehicle was set on fire by some unknown miscreants on charge that the above vehicle was involved in drugs business and fled away by taking the advantage of darkness. Further, the police team douse the fire but it was burnt beyond repair. Afterward, W. Ibocha Singh, MPS SDPO/TBL arrived at the spot. On searching the body of the individual in presence of W. Ibocha Singh, MPS, SDPO/TBL as Gazetted Police Officer witness, the police team found no incriminating articles. So, the suspected Codeine Phosphate & Triprolidine Hydrochloride Syrup of 100 ml capacity including the burnt vehicle Santro bearing No. Nil was seized by preparing a formal weighing and seizure memo from the possession of accused Md. Fajur Rahaman (48) S/O (L) Md. Sanamanik of Sangaiyumpham Part II Cherapur Makha Leikai in presence of witnesses on 04/09/2023 at 2.00 am and arrested the accused person Md. Fajur Rahaman (48) S/O (L) Md. Sanamanik of Sangaiyumpham Part II Cherapur Makha Leikai by preparing a formal arrest memo in presence of witnesses on 04/09/2023 at 2.10 am.

The arrested person along with seized items are handed over to you for taking further necessary legal action against him.
