Today i.e. 17/9/2023 at 5:15 pm, received an information that on the same day at about 5 pm, one scooter Honda DIO bearing regd. no. MN01F6414 proceeding from Thoubal Khunou towards Thoubal Okram side along Thoubal college road met a road traffic accident with one motorcycle Royal Enfield bearing regd. no. MN01AB5638 proceeding from Thoubal towards Imphal side along NH102 at Thoubal Okram near Waikhom Mani Girls College along NH102 due to rash or negligent riding on the part of unknown riders of both two wheeler vehicles. As a result of it, the unknown riders of both vehicles sustained injuries on their persons and evacuated to hospital for medical treatment as well as both vehicles were also badly damaged.

Hence, a suo-motu case FIR No. 166(9)2023 TBL-PS u/s 279/338/427 IPC has been registered for investigation.
