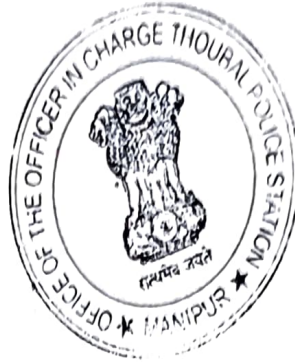




Sir,
