

As per endorsement, I have the honour to report that on 18/09/2023 at 7.30 am, one Kh. Tomba Singh, Secy. REEDO, Wangbal Part-I have submitted a missing report stating that on 18/9/2023 at about 3:30 am, one Thongram Sadananda Singh aged about 14 yrs s/o late Th. Ibungo @ Ibungcha Singh of Wangbal Heiruthong who is an inmate of NAWA SANGLEN (Children Home for boys) run by Rural Educational and Economic Development Organisation (REEDO), Wangbal Part I, Thoubal District, Manipur was found missing. A hectic efforts to trace out the missing boy was carried out, however his whereabouts could not be known. It is refer to vide GD entry No.09/TBL-PS/2023 Dt.18/09/2023.

On enquiry, a hue & cry message has been sent to all Osc PSs in Manipur to trace out the missing boy vide msg. signal No.28/TBL-PS/2023/424 Dt.18/09/2023. Examined the complainant, some PWs and inmates as well as staffs of the said home. It is ascertained that the missing boy from the said home is found genuine and suspected to have been kidnapped by some unknown miscreants.
