Subject: Report



Sir,

I am to report that today i.e. 13/08/2023 at about 4 pm my wife namely Soram (O) Anita Devi of Yairipok Bamon Leikai went to our paddy field located at Leingang Khongnagkhong on the eastern side of Yairipok Pechi road by riding one Honda Activa 5G bearing No. MN01AJ - 3272 brown in colour recorded in my name. She reported that she parked the Honda Activa on the road side of Yairipok Pechi road near Leingang Khongnagkhong and she was working to our paddy field. At about 5:56 pm of today she shows one Alto car Merun in colour came from Pechi side towards Yairipok Bazar side and stopped the Alto car where my Honda Activa parked. Then two persons came down from the Alto car and two persons were inside the said car. Suddenly, among the two, one person ridden my Activa towards Yairipok Bazar side and three others ran away by driving the Alto car towards Charangpat side via Yairipok Charangpat IVR. My stolen Activa along with the person who stolen my Honda Activa have been chased and detained by the people at Yairipok Charangpat IVR near public waiting shed. The approximate value of my Honda Activa is Rs. 90,000/- (ninety thousand) only

The accused person namely BM. Iliyas (25) yrs. S/o Md. Zakir Hussain of Lilong Shangomshang Shuktukarong along with my above mentioned Honda Activa have been handed over to your PS for taking further necessary legal action.
