With due respect, I have the honour to state that on 13/06/2023 OC/HRK-PS endorsed to me one missing report vide GD No. 14/HRK-PS/2023 dated 13/06/2023 for enquiry in c/w the missing of one Khundongbam Somen Singh 36 years S/o Kh. Piktru Singh of Heirok Part-III Ngarouthel Laishram Leirak, P.O-Wangjing, P.S-Heirok, Thoubal-District, Manipur on 10/06/2023 at around 09:00 am from his residence and same could not be traced out till date. Accordingly I have taken up the missing report and enquire into.

During the course of enquiry, I have send out a WT message to all OsC PSs in Manipur for making a sharp look out in their respective PSs jurisdiction, but no any intimation has been received till date. However, the missing person could not trace out and whereabouts is not known till date. Examined many persons including one Khundongbam Chaoba Singh, who is elder brother of the missing person and there is suspicious that the missing person might have been abducted and wrongfully confine by some unknown person/persons.

It is therefore submitted the enquiry report for favour of taking further necessary legal action.
