On 09/09/2022 at about 3 p.m firstly wrongful confinement, for illegal acts subsequently at about 9 pm committed rape by committing breach of trust, cheating and threatening acts against the will of the complainant, at the resident of the accused no.2 and continuing criminal intimidation within the jurisdiction of this Hon'ble Court.

**Most Respectfully Sheweth:**

1. That, the complainant is a bonafide citizen of India having permanent residence in the state of Manipur. As such, she is entitled to all the rights, privileges and protection enshrined in the Constitution of India as well as any other laws enforce in the state.
  
2. That, the accused no.1 is a personal of Gorkha Regiment, now posted at Noney Bn. He is well acquainted with the complainant and also love affairs since about 5/6 months ago. Sometimes they met and talk on telephone. On 09/09/2022 at about 1 pm they meet at Imphal, the accused no.1 proposed for having a cup of tea at a suitable place but denied by the complainant. However, the complainant and accused no.1 by a two wheeler vehicle came towards Imphal Yairipok via Ngarian Road. When they reached at Yairipok, the accused no.1 proposed for having a cup of tea at the resident of his elder sister residing at Yairipok Khoirom (Accused no.2). The complainant without any hesitation as the accused no.2 is the sister of accused no.1 came and seated there, for a while for having a cup of tea.
  
3. That, at about 3 pm, while they were seating at the resident of the accused no.2, the accused no.1 in collusion with accused no.2 and by conspiring each other lock the door of the room and wrongfully confine the complainant till 9 pm of the day. The complainant shouted for help and requested to the accused no.1 & 2 and tried to get rid of from the place but in-vain. Thereafter, the accused no.1 forcibly physically touched the complainant and out raged of her modesty and forced for committing rape. The complainant resisted as far as practicable. The accused no.1 torn the blouse of the complainant and by taking undue advantage of weakness and loneliness forcibly committed rape two times against the will of the complainant. Under wrongful confinement of the whole night, the accused

no.1 committed outrage of her modesty and rape of the complainant on criminal intimidations and under coercion.

4. That, while the complainant was under lock and key, on telephone she informed to her mother that she is now at Yairipok and she is in a critical position but the accused No.1 snatched her mobile phone and concealed. The parent of the complainant rushed towards the site but could not meet them on that night. In the morning of 10/09/2022 the parents of the Complainant rushed towards the resident of the accused no.2. In the meantime the accused no.3 who is the father of the accused no.1 & 2 and accused no.4 (pradhan of the locality) by threatening the complainant and her parents they forcibly took signatures of the complainant and her parents on some non judicial stamp papers. They threatened for signing on the said blank non judicial stamps and also informed that they will write on the said non judicial stamp papers that the complainant and her parents will not complaint/ demand anything for the said criminal acts committed by the accused no.1. They also threatened that in the event of refusal to sign on the said non judicial stamp papers, the life of the complainant and her parents will be endangered. They also threatened that in the event of any discloser of their illegal acts or complaint to the police/NGO'S forum/Court, they will killed the complainant and her family.
5. That, surprisingly in the month of April 2023, a legal notice from one Meelar, Advocate C/o Yumnam Devadutta (advocate), served a legal notice to the complainant. In that legal notice, the counsel of the accused no.1 alleged that the complainant and her father used a Sum of Rs. 21,50,000/- (Twenty one lakhs fifty thousands) only, from his client(Accused no.1) on the assurance of the repayment of the same. And requested for repayment. Not only this the accused no.1 threatened to the complainant, by saying that **do you want to marry him or do you want to pay a sum of Rs. 21,50,000-/(Twenty one lakhs fifty thousands) only, choose which you like ? .**
6. That, the accused no.1 is arrogant, whimsical in nature. Recently, the complainant came to know that the accused no.1 is a married person having wife and children. He cheated the complainant that he is a bachelor and proposed for love affairs. He committed breach of trust and on cheating he committed wrongful confinement of the complainant for illegal acts and by taking undue advantage of weakness and loneliness of the complainant, he committed rape two times against the will of the complainant. Thereafter, the accused persons on conspiracy continuing threatening acts to the complainant and her family members by taking law into their hands.



7. That, due to fear of the accused persons, the complainant could not report the matter to the concern police or Magistrate because they threaten that in the event of any complainant by the complainant and her family members regarding the matter they will killed the complainant and her parent. One day in the month of March 2023, at about 11:30 pm the accused no.1 came at the residence to the complainant and also threatened to killed her. However, on 14/04/2023, the complainant reported the matter to the O.C Yairipok P.S by lodging a complaint. But the O.C. Yairipok P.S. refused to received the complaint on the ground of delay of report. Having no alternative, the complainant ready to file a complaint case before this Hon'ble Court for taking cognizance against the accused persons as **Narazi complaint** but unfortunate incident of the clashes between Meiteis and Kukies which were broken out since 03/05/2023 and abnormality of Law and Order situation in the State, the complainant could not file the complaint timely and prayed for pardoning delay.
8. That, on 09/09/2022, the accused no.1 and 2 wrongfully confined the complainant for illegal acts. Later on, the accused no.1 committed outrage of her modesty and committed rape of the complainant two times against her will. The accused no.3 and 4 by putting the complainant and her parents under fear and forcibly took signatures of the complainant and her parents on some non judicial stamp papers under criminal intimidation. They committed offences under Sections 406/420/347/354/376/506/34 IPC within the jurisdiction of this Hon'ble court.
9. That, the complainant is a simple village girl and also from a remote area. She has lack of Legal knowledge. By taking undue advantage of her weakness and innocency, the accused persons by taking law into their hands, they committed heinous offences to the innocent complainant.



In the above facts and circumstances your honour be pleased

- to take cognizance of the offences.
- to issue warrant of arrest the accused persons.
- to punish the accused persons according to law, for ends of justice.
