Subject: - Report.

Sir,

I beg to state that today i.e. 25/09/2023 at about 3.30 am received a reliable information that some unknown armed miscreants have hidden some arms, ammunitions and explosives at Khoirom Laijing foot hill near hand pump for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 33 AR Thoubal, COB led by Addl. SP(Ops), TBL assisted by OC CDO/TBL and one team of Yairipok PS under the supervision of SP/TBL have rushed to the spot immediately and launched a massive operation at 04:00 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 1 (one) no. of SLR bearing No. AA2957 (2) 07 (seven) nos. of SLR magazines (3) 1(one) Anti-Riot gun bearing No. 2K18-26093 and (4) 1(one) no. 36 HE (High Explosive) Hand Grenade without detonator from the spot i.e. Khoirom Laijing foot hill near hand pump at 05:20 am.

Further, seized the aforesaid articles at 05:40 am by observing necessary formalities. The massive searched operation was conducted from 04:00 am to 06:30 am on the same day.

It is therefore, handed over the seized articles to you for taking further necessary action.
