That, we are the resident of New-Keithelmambi village, Imphal West District which is situated along NH-37 and it is a village of mixed communities. That, about 150 meters from our village, there is a village known as New-Keithelmambi Kuki village which is residence of Kuki peoples, that on 10/05/2023 at @ 6:50 PM some unknown persons numbering about 15/20 suspected to be Kuki militants approached near our house & tried to attack in our life and family members. In view of the prevailing situation, there is some certain threats and imminent dangers in our life and properties from the unknown persons suspected to be Kuki militants. So, we along with our family members are in great fear in future due to threat and living in a condition to leave the villages.

Therefore, it is requested to take necessary action so as to safeguard my life and properties as per law.
