Today i.e, 10/08/2023 at around 1.30 pm crowed numbering about 1000 people including women gathered at Ema Market, Jiribam by holding Placards for marching a rally which was organised by LEECHING, Jiri led by L. Ranjan Singh, convener and W. Dinesh Meitei, Chairmen LEECHING, Jiri in and around Jiribam Municipal area by violating the prohibitory order passed by the District Magistrate, Jiribam under Sub-Section 2 of Section 144 of Cr.P.C, 1973 from 10.00 am to 5.00 pm of date ( 10/08/2023) at about 2.30 pm at Ema Market, Jiribam. Rather, the public gathered there random increasing its number and become more violent to the rest of the security forces and turned into an unruly mob. Further, they started pelting stones towards Security personnel and burnt down two numbers of Traffic Police Boots located at near Bazar area and Irabot crossing respectively. As the crowed turned furiously violent and out of controllable, and as there is no alternative/option means, maximum force was rushed and also fired Tear Gas shell to disperse the unruly mob. In the said incident, 3 (three) security personnel namely (1) C/No. 0915046 T. Ginthiankham of JBM-PS, (2) C/No. 1815324 Th. Bikram Singh, escort to SP/JBM and (3) GD No. 13502133 Raj Narayan Bharti of 120 Bn. CRPF, "D" Coy were received injury on their persons and the one Scropio bearing registration No. MN 01A-3565 allotted to SP/JBM was also partly damaged. The said unruly mob was dispersed on the same day at around 6.30 pm.

Hence, a regular case under FIR No. 36(08)2023 JBM-PS U/S. 147/148/149/188/325/427/436 IPC has been registered on suo motto for investigation.
