In view of the prevailing situation, there is some certain threats and imminent dangers in our life and properties from the unknown persons suspected to be Kuki militants. So, we along with our family members are in great fear in future due to threat and living in a condition to leave the villages.

Therefore, it is requested to take necessary action so as to safeguard my life and properties as per law.
