Today i.e 29/06/2023 at 9:00 pm received an information that at about 8:50 pm of date a large numbers of crowd numbering about 1,000 (one thousand) coming from different directions were gathered at keishampat junction and forced to give a way to enable them to meet the Hon'ble C.M. Shri N. Biren Singh. The police teams and the RAF personnel who were deployed at Keishampat Junction and BJP office area warned the crowd to disperse and go back home peacefully but the crowd became unruly and violent. Then, the police and the RAF had obtained written permission from the Executive Magistrate to disperse the unruly mob and given warning to the unruly mob to disperse within 10 minutes. However, the unruly mob became more violent and started pelting stones to the security forces by using catapult. Then the police and RAF forces dispersed unruly mob by using non-lethal means i.e. smoke bomb, tear gas and lathis. 7(Seven) persons were detained from the spot. They are:-
