Today i.e. 28/07/2023 at 08.30 pm., received a reliable information that on the same day i.e. 28/07/2023 at around 08.25 pm., one Maruti Alto Car, Silky Silver in colour, bearing registration no. WB02AA-0584 driven by an unknown driver, plying from Kakching side towards Thoubal side, dashed on the rear side of one Tata, White in colour, bearing registration No. MN04C-0642 which was parked at Sangaikhong, along NH No. 102, due to rash or negligent driving on the part of the unknown driver of Maruti Alto Car. As a result of which unknown driver and one occupant of Maruti Alto Car, sustained serious injuries on their persons and evacuated to District Hospital Thoubal for medical treatment. And the involved vehicles in the accident were also partly damaged.
