Today, i.e. 17/09/2023 at 4.45 pm, received a reliable information that on the same day at around 4:30 pm one Vehicle Jupiter 125 dark orange in Colour bearing registration No. nil plying from Khongjom side towards Wangjing side ridden by an unknown rider dashed another Vehicle Activa 125 black in colour bearing registration No. MN 01A-N1376 plying from same direction i.e. Khongjom side towards Wangjing side near the Uningkhong along NH No. 102, due to rash and negligent driving on the part of vehicle Jupiter.
