Subject:- Enquiry report.

Sir,

I have the honour to submit the enquiry report of stolen of two wheeler "Honda Activa 6G" bearing Regd. No. MN01AM-3187 Maroon in colour from Waithou Bazar near Coffee Culture. The brief fact of the case is that on 13/07/2023 complainant namely AK. Anand Singh (36) yrs, S/o. AK. Binoy Singh of Thoubal Mayai Leirak reported to OC/Lilong PS stating that on 11/07/2023 at about 06:30 pm his Honda Activa 6G bearing Regd. No. MN01AM-3187 Maroon in colour which was parked at Waithou Bazar near Coffee Culture was stolen by unknown person(s). It referred to GD Entry No. 24/LIL-PS/2023, dated: 13/07/2023 and endorsed to me for enquiry.

As per endorsement, I have enquired into the matter and sent a W/T message to all OCs of all PS in Manipur to make a sharp look out of the stolen vehicle at their PS jurisdiction and also intimate the matter to my personal source.

In the meantime on 13/07/2023 at about 02:00 pm received a reliable information from my personal source that the stolen Honda Activa 6G was seen using by 2 (two) persons namely: i) Bm. Amir Hussain (28) yrs, S/o. Bm. Abdul Samad of Lilong Turel Ahanbi near Ubakthong Makha & ii) Md. Amir Khan (22) yrs, S/o. (L) Md. Suleiman of Lilong Turel Ahanbi near Ubakthong Makha. After getting the information, I along with SI. Ksh. Gyaneshwor Singh & SI. Md. Wakibuddin rushed to the house of Md. Amir Khan (22) yrs, S/o. (L) Md. Suleiman of Lilong Turel Ahanbi near Ubakthong Makha and then searched him for enquiry but he was not found at his residence so narrated the matter to his family member and they also try to the contact Md. Amir Khan phone but his phone was switch off, thus left the house of Md. Amir Khan and rushed to the house of Bm. Amir Hussain (28) yrs, S/o. Bm. Abdul Samad of Lilong Turel Ahanbi near Ubakthong Makha. On reaching the house, he was searched for enquiry but he was not found at his residence so narrated the matter to his family member. In that one of his brothers namely Hassan call up his brother Bm. Amir Hussain from his phone and talk about the matter and he told that they i.e. Md. Amir Khan & Bm. Amir Hussain had stolen the said Honda Activa 6G from Waithou Bazar near Coffee Culture and kept sold out to one unknown person from Yairipok at Rs. 18,000/- (eighteen thousand).

On further enquiry, Hassan (brother of Bm. Amir Hussain) and Md. Wahajuddin, S/o. Zakir @ Abdul Salam of Lilong Turel Ahanbi has assure me that they will hand over the said stolen Honda Activa 6G to Lilong PS by 04:00 pm of the same day but they neglect the assure they given to me. Thus on the next day i.e. 14/07/2023 at around 08:30 am again rushed to the houses of both persons to caused arrest not both the accused persons were not found at their respective house and moreover issues summon to them on 17/07/2023 to appear to Lilong Police Station but they were not appear to this PS till today.

It is therefore requested to take up necessary steps to cause arrest the above accused persons in timely.
