Sir,

I have the honour to report that today i.e. 29/07/2023 at about 4:30 a.m. received a reliable from my own source about Heroin powder were kept conceal at the residence of Makakmayum Shahnawaz Khan (36), s/o. Md. Asraf Ali of Kaleikhong Thong Mathak, Lilong Haoreibi Turel Ahanbi for selling to the drug users. Accordingly, after verifying the veracity of source report, the information was taken down in writing and a copy of the same was forwarded to Inspt. K. Nitaranjan Singh, OC/CDO, Thoubal for kind information and further necessary action. Accordingly, I obtained the search authorization from Senior Superintendent of Police, Thoubal. Immediately, organized a combined team of Commando Unit Thoubal led by Inspt. K. Nitaranjan Singh, Officer-in-Charge Commando Unit, Thoubal assisted by HC. Sh. Suraj Singh under the command of Shri Wangkhomba Okramcha, MPS, Addl. SP (Ops)/Thoubal and under the supervision of Shri. Sachidananda Soibam, MPS, Superintendent of Police, Thoubal District, Manipur with necessary equipment rushed to the residence of Makakmayum Shahnawaz Khan (36), s/o. Md. Asaf Ali of Kaleikhong Thong Mathak, Lilong Haoreibi Turel Ahanbi PO&PS Lilong, District, Thoubal, Manipur. On reaching the spot, our police party cordoned the said residence and was able to detain one person who identified himself as Makakmayum Shahnawaz Khan (36), s/o. Md. Asraf Ali of Kaleikhong Thong Mathak, Lilong Haoreibi Turel Ahanbi, PO & PS: Lilong, District. Afterwards, I offered him whether he would want his body and his belongings and the house to be searched in the presence of Gazetted officer or Executive Magistrate or civil witnesses. In that, he offered his body and belongings and the house to be searched in the presence of a Gazetted officer. Accordingly, I informed Shri O. Wangkhomba, MPS Addl. SP(Ops), Thoubal at 5:30 a.m. to be witness of the search of body and belonging of the above individual. On searching his body in presence of Shri O. Wangkhomba, MPS Addl. SP(Ops), Thoubal, the police team found no incriminating articles from his possession.

Further on searching his house, our team found one black plastic polythene concealed under the bedroom. On opening the black plastic polythene in presence of Gazetted officer, found 5(five) soap cases and 2(two) plastic transparent packet. On checking the soap cases and plastic transparent packet, it was found to contain a brownish powdery substance, wrapped with transparent plastic packet which is suspected to be illegal heroin brown sugar are then marked by the undersigned as "A", "B", "C", "D", "E", "F", "G". and then weighed and found out to weigh 15 gm, 16 gm, 12 gm, 19 gm, 12 gm, 17 gm and 17 gm respectively excluding the weight of the container i.e. soap cases. Afterwards, the above suspected heroin brown sugar was weighed by using weighing machine and found a total of 108 gms. including the weight of the transparent plastic.

Finally, the above exhibits A, B, C, D, E, F, G were sealed and packed in front of the Gazetted officer and seized by observing formalities at 6:00 a.m. by preparing a formal seizure memo from the possession of Makakmayum Shahnawaz Khan (36), s/o. Md. Asraf Ali of Kaleikhong Thong Mathak, Lilong Haoreibi Turel Ahanbi and arrested the accused person namely Makakmayum Shahnawaz Khan (36), s/o. Md. Asraf Ali of Kaleikhong Thong Mathak, Lilong Haoreibi Turel Ahanbi, PO&PS Lilong, District, Thoubal, Manipur by preparing formal arrest memo at 6:10 a.m.

The arrested person along with seized items is handed over to you for taking further necessary legal action.
