Sir,

I have the honour to report that on 04/08/2023 at about 5.20 pm, while my younger brother namely Md. Zakaullah aged about 22 yrs was driving his Tata Magic bearing registration No. MN06L-4571 white in colour for selling of drinking water suddenly Md. Asker Ali aged about 42 yrs S/o. Late. Md. Nasib Ali of Lilong Haoreibi Awang Leikai had fired one live round from a short gun may be like 9 mm to my younger brother Md. Zakaullah when he reached near the Purana Masjid Lilong Haoreibi Awang Leikai but no any casualty there. Then my younger brother went to save his life at the house of my sister at Lilong Leihaokhong and parked his vehicle at the entrance gate of my sister house. In the meantime, his Tata Magic was forcibly taken away by the said Md. Asker Ali and Md. Imran aged about 27 yrs of Lilong Leihaokhong Leinung Hotel and some other unknown associates from the above noted place. Thereafter, while I was searching the whereabouts of my younger brother, Md. Asker Ali and his associates had assaulted me at Lilong Leihaokhong Leinung Hotel without giving any reasons by punching and kicking. As a result of which I got abrasion on my mouth.

It is therefore, requested to take up necessary legal action as per provision of law against the culprits.
