Sir

I have the honour to state that on 08/08/2023 my younger brother namely Md. Tamijur Rahaman 28 yrs S/o. Haji Anwar Ali Khullakpam of Lilong Masjid Road eloped one Miss Shahenaz Sultana FM 25 yrs D/o. Haji Salauddin of Lilong Turel Ahanbi, Sirinthong by her consent and they also took court marriage. On the next day i.e. on 09/08/2023 as per customary law, the information of eloping was given to her family member. Thereafter, on the same day in the evening both the family members have agreed to be living Md. Tamijur Rahaman and Miss Shahenaz Sultana FM as husband and wife and also paid Rs. 10,00000/- (ten lakhs) as a Mohrna of Miss Shahenaz Sultana FM by my father. On 15/08/2023 at 2.00 pm my family members had went to the house of the Haji Salauddin of Lilong Turel Ahanbi, Sirinthong along with my daughter in-law namely Miss Shahenaz Sultana FM by observing customary law. Then, my family members including Women and Children were detained by some known persons led by Haji Salauddin at his house and asked to bring Rs. 5,00000/- (five lakhs) on the next day. They also threatened and beat up my family members and also told that he will never give his daughter in the future. The family members of Haji Salauddin and some known persons kept his daughter at his house and latter our family members were released.

They also charged our family members that the elopement was against the consent of Miss Shahenaz Sultana FM, 25 yrs. after taken all the money that had been mentioned above. So, I therefore requested you to kindly take necessary legal action against the culprit as per the law at the earliest.
