Mane Khan @ Kalenjao of -do, 4) Miss Farana aged about 23 yrs D/o. Md. Mane Khan @ Kalenjao of -do, 5) Mrs. Souda 35 yrs W/o. Md. Samir Khan of -do, 6) Miss Nargish 25 yrs D/o. Md. Washim aged about 19 yrs, 2) Miss Rufajan aged about 21 yrs. As a result of which my family members were received injuries and evacuated to Hospital for medical treatment. The act of the above noted accused persons is attempted to kill me and my family members with intention.

Therefore, I earnestly request you to take appropriate legal action against the above noted persons.
