Sahir aged about 21 yrs S/o. Md. Mane Khan @ Kalenjao of Lilong Ushoipokpi Mathak, 2) Md. Achouba aged about 20 yrs S/o. Md. Ayub Khan of -do- and 3) Miss Nargish aged about 22 yrs D/o.
