Subject : Complaint against Dr.Lamtinthang Haokip
(@DrLamtinthangHk) with request to investigate,
register an FIR, arrest and punish the said person, as
per law.

Sir,

This to lodge a complaint against Dr.Lamtinthang Haokip
(@DrLamtinthangHk) with a request for making an enquiry
and lodging an appropriate FIR, investigating and punishing
the said person, as per law established.

It is pertinent to note that there has been large scale violence,
mayhem, killing, arson etc. between the Kuki-Zo community
and Meitei community in the State of Manipur since
03.05.2023. One of the reason for said large scale violence is
a result of provocative speech, tweets, false and fake viral
video's and imputations made by way of posts uploaded
through social media platforms and other mediums resulting
in promoting enmity between different groups and
communities and thereby further promoting communal
disharmony, feelings of enmity, hatred, ill-will between
different classes and communities and also disturbing the
peaceful co-existence and harmony of different communities
in the State of Manipur and more specifically the Kuki-Zo and
Meitei community. The situation is still volatile as more than
150 lives has been lost and thousands of persons being
rendered homeless and displaced.

In the backdrop of such a situation where efforts have been
made from all concerned to ensure that peace and normalcy
returns in the State of Manipur as soon as possible, the said
person, namely Dr. Lamtinthang Haokip
(@DrLamtinthangHk) has uploaded a tweet on 12.08.2023
through "Twitter" in his twitter account
"@DrLamtinthangHk" naming Hon'ble Prime Minister – Shri
Narendra Modi and Home Minister – Shri Amit Shah as
"criminal combine" and stating that they are real threat to

sedition, defamatory / libellous statement has been made stating that Hon'ble Prime Minister -Narendra Modi and Home Minister -Amit Shah, after overpowering parliament, they are heading towards the target of SC and Election Commission.

Thereafter, in the same second para of the said tweet, the said person makes further false, derogatory, seditious, defamatory / libellous statement that the Hon'ble Prime Minister -Narendra Modi and Home Minister -Amit Shah, are simultaneously targeting independent intellectuals claimed to be belonging to the community of the said person (i.e., Kuki-Zo community).

The said person also makes further false, derogatory, defamatory libellous statement that :- *"Recently, in collusion with Manipur CM @NBirenSingh some reputed names of the #Kuki-Zo community associated with Hyderabad University, JNU and Manipur University have been framed on false cases/allegations to silence their voices."*

In the last para of the said tweet, the said person states:- *"Its high time the citizen of India to resist their conspiracy and evil design of doing away with the ideal principles of India's Democracy."*

The said imputations and naming the Hon'ble Prime Minister – Shri Narendra Modi and Home Minister – Shri Amit Shah as *"criminal combine"* are ex-facie false, derogatory, seditious, defamatory being libellous statement. The further statements made by said person that Hon'ble Prime Minister - Shri Narendra Modi and Home Minister – Shri Amit Shah, are simultaneously targeting independent intellectuals claimed to be belonging to the community of the said person (i.e., Kuki-Zo community) are also ex-facie false and bereft of any truth, provocative and has been aimed at promoting further communal disharmony, feelings of enmity, hatred, ill-will between Meitei Community and Kuki-Zo Community and to further escalate the already disturbed co-existence and existing disharmony between different communities in the State of Manipur. The said false imputations is malignantly aimed at promoting further rioting, killing in the State of Manipur, by falsely imputing that Hon'ble Prime Minister - Shri Narendra Modi and Home Minister – Shri Amit Shah are targeting Kuki Zo intellectuals.

The imputations and assertions that Hon'ble Prime Minister -

and Election Commission are prejudicial to national integration, as such false imputations which are ex-facie false, derogatory, defamatory has been made by said person being belonging to Kuki-Zo Community. The said person has failed to bear true faith and allegiance to the Constitution of India as by law established or uphold the sovereignty and integrity of India as said false imputation has been made to incite disharmony between the Legislature and the Judiciary of the Country, as the last para of the tweet calling upon "*the citizen of India to resist their conspiracy and evil design*" shows the mens rea and criminal intent of the said person, to spread the violence happening in the State of Manipur to the entire nation, by way of calling upon or abetting the Citizen on India to wage a war against the Government of India and escalate the war already waged against the State of Manipur by the Kuki Zo community by killing Police Personnels of the State of Manipur.

The imputations made by the said person that :- "*Recently, in collusion with Manipur CM @NBirenSingh some reputed names of the #Kuki-Zo community associated with Hyderabad University, JNU and Manipur University have been framed on false cases/allegations to silence their voices.*" is totally false, derogatory and are libellous statement as the Chief Minister, Manipur is not at all related with the said cases. This fact can even be known from the publications made in the local newspapers circulated in the State of Manipur, as it had been reported that some individuals in their personal capacities had filed some criminal complaint cases before the competent Criminal Courts in the State, against some persons associated with Hyderabad University etc. Hence, the imputations of the said person made against the Chief Minister, Manipur are ex-facie false and have been made only for the reason that the Chief Minister, Manipur does not belong to the Kuki-Zo community of the said person. The imputations against the Chief Minister, Manipur is to add more fuel to the already burning communal violence in the State, with a pre-designed motive to prejudice the national integration and to escalate the war already waged against the State of Manipur by causing further abetment.

The content of the tweet post is a written post and the said post has now gone viral in the social media and the said content is provocative and has further promoted enmity between different groups on grounds of being belonging to different community. The post seeks to escalate further

aggravating the war already waged against the State of Manipur where many State Police Personnel have lost their lives. The writer has intentionally by words written and visible representation, has made public in the social media platform to the world at large to further prejudice the maintenance of harmony and to ensure that peace does not return. The said person has further incited communal hatred, with a criminal intent to flare up the ongoing communal clashes amongst conflicting communities in the entire State of Manipur and which violence has even effected other States in the Country. The writer, by words written with signs of visible representations and false imputations, has deliberately and maliciously with a predesigned motive outraged the respectful functionaries of the Central and State Government being the Hon'ble Prime Minister and Hon'ble Home Minister by naming them as "criminal combine", and further maliciously dragged the name of Hon'ble Chief Minister, Manipur in criminal cases, having no relation to the Chief Minister, Manipur. Additionally, the said person has heaped insults to them. The written statement of the writer/ said person is intentional and has been made to cause further alarm to the public in order to incite the public to commit more offences against the State and to cause more disturbance to the public tranquillity, so that peace and normalcy does not return in the State of Manipur. The statements have further created and promoted more enmity, hatred, ill will between two communities of Meitei and Kuki-Zo as said statement in the tweet has also been made public through social media platform and circulated widely to cause alarming news, in order to achieve the malicious objective of causing more feelings of enmity between the two conflicting communities in the State of Manipur.

It is therefore requested to kindly investigate, register an FIR, arrest the said Dr.Lamtinthang Haokip (@DrLamtinthangHk) and punish him for the criminal offence committed by him, as per law.
