Today i.e. 24/08/2023 at about 9.20 pm received a reliable information that on the same day at 9.15 pm an unruly mob comprising women numbering about 200 of Lilong Nungei Meitei came and gathered at Lilong Nungei Awang Leikai in c/w the inter caste elopement of one Meitei girl and Meitei Pangal boy . Then the said unruly mob cause damaged/destroyed two houses of Lilong Nungei Awang Leikai. The unruly mob also disturbed the discharging of lawful duty of the police personnel present at the spot by pelting stone. Later, dispersed the mob at 11. 50 pm. In the meantime, learnt that one women is evacuated to Hospital by her relatives for medical treatment.

Hence a suo motto case under FIR No. 67(08)2023 LIL-PS u/s 147/148/149/325/353/427/34 IPC has been registered for investigation.
