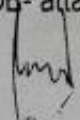

So, I left my vehicle there thinking that until normalcy restore in Manipur. But shockingly, when I track my vehicle on the mentioned above date it was not there in the location and move to different location within Manipur. The last location was NH2 Ningthoukhong Awang Part near Indian Oil Petrol Pump, Bishnupur Dist. Manipur-795126 after that SUZUKI CONNECT has lost its connectivity.

We have tried all possible means but failed. I request you to kindly trace my vehicle whereabouts and took necessary Action against the culprit.
