**Subject:** - Complaint/ Report on crimes of looting and vandalism of properties / discrimination of Scheduled Tribes.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the **any Kuki Tribe**, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under the **SC/ST (Prevention of Atrocities) Act, 1989**.

That, due to the prevailing ethnic crisis in and around Imphal, my daughter namely, **Neikhoneng Haokip**, aged about 28 years, a student of Dhana Manjuri (DM) College, Thangmeiban, Imphal East, pursuing her 4<sup>th</sup> Semester in Bachelor of Education (B.Ed), rented a house located at Awang Chaokhong near North AOC, **P.O., P.S.- Imphal (city police) and district- Imphal West**, made an escaped from her rented house on the 4<sup>th</sup> of **May, 2023** at around **10:30 AM**, taking refuge at 2<sup>nd</sup> Manipur Rifles (M.R.) and with the help of the Central Forces jawans, she was escorted to Imphal Airport, there she boarded an aircraft to New Delhi, staying with her cousins to this day.

That, along with the looted and vandalized properties (her personal belongings, kitchen stuffs and Misc.) my daughter left her two-wheeler bearing regn. No. MN02 B 4719, make&model is Honda Activa 3G, brown in colour, at the parking lot of the said premises, the condition and the whereabouts of the said vehicle is not known till date. The total value of the mentioned properties along with the said vehicle is estimated to be about **Rs.2,50,000/- (Rupees Two Lakhs Fifty Thousand)** only.

In the given circumstances, I assumed that my daughter had already file a ZERO FIR from the nearest Police Station where she currently resides (New Delhi), apparently that doesn't seem to be the case so I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. And, thus I am filing the report lately today.
