

Subject: - Complaint/ Report on crimes of looting and vandalism of properties / discrimination of Scheduled Tribes.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the **Paite Tribe**, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **the SC/ST (Prevention of Atrocities) Act, 1989.**

That, due to the prevailing ethnic crisis in and around Imphal, my youngest sister namely, **Chingbiakmawi**, aged about 27 years, a student of Dhana Manjuri (DM) University, Thangmeiban, Imphal East, pursuing her Doctorate in Education (PhD) bearing admission Roll. No. **EDU-22/002**, rented a house owned by **Shaheen(9774594996)** located at Zomi Villa near North AOC, **P.O. & P.S.- Imphal (city police) and district- Imphal West**, made an escaped from her rented house on the **4th of May, 2023** at around **8:30 AM**, taking refuge at **2nd Manipur Rifles (M.R.)** and with the help of the Central Forces jawans, she finally made it home, located at Vengnuam, New Lamka, Churachandpur district. And, since its impossible for her to go back and continue her Research, she left for New Delhi via Aizawl, Mizoram, staying with her cousins **and with the hope to continue her further Research.**

That, the looted and vandalized properties include such as- "**Research tools, Personal Belongings, Kitchen items, Electronic appliances and Misc**". which is estimated to be about **Rs. 2,20,000/- (Rupees Two Lakhs Twenty Thousand)** only.

In the given circumstances, I assumed that my said Sister had already file a ZERO FIR to the nearest Police Station where she currently resides (New Delhi), apparently that doesn't seem to be the case so I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. And, thus I am filing the report lately today.
