I have the honour to report that on 07/09/2023 at about 4.30 pm my son namely Md. Saroj aged about 19 yrs along with his 02 (two) friends namely 1) Md. Ashad Ali S/O. (L). Md. Basir Ahmed of Urup Awang Leikai and 2) Md. Riyas S/O. Md. Abdul Manap of Kyamgei were coming a motorcycle KTM-RC bearing Regd. No. MN01AG-3139 ridding by my son from Lilong Bazar side towards Thoubal side was dashed by one Four wheeler Van bearing registration No. MNO4A-1984 blue in colour coming in the same direction driven by unknown driver at Waithou corner near Coffee Culture along NH-102. As a result of which, my son and his 02 (two) friends got serious injuries on their person and evacuated to Hospital for medical treatment. I couldn't report the matter in time while engaged in treatment of my injured son and his friends.
