I have the honour to state that on 22/08/2023, at about 7.30 p.m., while I along with some customers of Jio Fibre Internet connection and 02 Technicians of the said company were undergoing to fix technical mal functioning of the connection which I used for my official purpose, the following 02 persons namely:

Started to disturb the process by using provocative foul languages blaming me without any reason. The said 02 persons were fully drunked at the moment.

Later a heated argument was ensued between us and the said persons mentioned above.
