

Today i.e., 15/09/2023 at about 9.45 am received an information that on the same day at about 9.40 am one Four Wheeler I-10 car (Magna) bearing registration No. MN03P-2489 grey in colour which was coming from Thoubal side towards Imphal side knocked down one unknown cyclist coming from same direction along NH-102 Lilong Bazar near Bridge due rash and negligent driving on the part of the unknown driver of Four Wheeler I-10 car (Magna). As a result of which, both the cyclist and the driver of the Four Wheeler I-10 car (Magna) received injury on their persons and evacuated to hospital for medical treatment. Both the involved vehicle and cycle were also partly damaged.
