Sir,

I have the honour to report you that the detailed team of Dr. Rajo's House guard reported that today i.e. 27/8/2023 at about 02.20 am some unknown armed miscreants suspected to be members of valley based unlawful organisation numbering about 4 (four) in camouflaged uniform and masked forcibly entered inside the house guard cum escort security barrack of Dr. Kangujam Rajo Singh at Sagolband Bijoy Govinda, overpowered and snatched away the following arms and ammunitions from the police on duty.

Details of the arms and ammunitions:-

- 1) 1 (one) AK-Ghatak No. 193901264 with 60 ammunitions in two magazines.
- 2) 1 (one) INSAS (folding) No. 18277591 with 20 ammunitions in one magazine.
- 3) 1 (one) Carbine No. MM-5353 with 25 ammunitions in one magazine.

Further, the arm miscreants suspected to be the members of valley based unlawful organisation fled away in a whit Gypsy.


You are therefore requested to take up necessary legal action against the unknown arm miscreants suspected to be the members of valley based unlawful organisation.
