Sir,

With due respect, I, **Khoirom Ronikumar Singh**, aged about 54 yrs., a resident of Khurai Ahongei Leikai, Imphal East District, P.O.- Lamlong, P.S. - Porompat serving as "Work Supervisor" to the ongoing construction of Chandramukhi Mall at Babupara, Imphal West and opposite side of BSNL Bhawan, Babupara, Imphal West beg to state that one incidence has been occurred at our construction site labour barrack on 27/08/2023 around 5:00 pm. At the same time, **Md. Ayan**, S/o Md. Johny, a resident of Babupara, Imphal, P.O./P.S./District - Imphal West near Masjid & his team was suddenly entering into our labour barrack and intentionally attempted life of **Dilip Halder**, aged about 45 years from **West Bengal** hitting by brick on head. Now, he is undergoing treatment at the Regional Institute of Medical Sciences, Lamphelpat, Imphal, Manipur due to injury. Relevant documents are enclosing herewith for your kind reference. **Dilip Halder** is our labour and innocent people. We have apprehension in this present situation.

Therefore, I would like to request that you may kindly take up legal action against the mentioned above cruelties at an early date purely on humanitarian ground. For which act of your kindness I shall ever pray to you.
