Today i.e 30/08/2023 at 6.24 pm received information that today at about 6.10 pm some unknown armed persons in combat uniform and masked with black cloth who came on a numberless white Gypsy have forcibly kidnapped one person namely Soubam Rajiv Singh aged 35 yrs S/o S. Apabi Singh of Sagolband Thingom Leikai, Manager QK Chicken Shop, near Keishampat Top Leirak. The kidnapped person was taken inside the Gypsy and fled away towards South along Tiddim Road. The unknown armed persons are suspected to be the members of valley based unlawful organization. The exact reason for kidnapping him is not known so far. But, likely for ransom.

Hence, a case suo-mottu case under FIR NO. 723(08) 2023 IPS u/s 364-A/342/506/34 IPC, 25(1-B) A. Act & 20 UA(P) Act has been registered against the unknown kidnappers suspected to be the members of valley based unlawful organizations for investigation.
