

As per press report dated 2nd September, 2023 of the Peoples Chronicle, it has come to known that in a press meet at Heirok Part II Umang Leikol on 01/09/2023 Phambei spokesperson Ningthouja Lancha announced for observance of September 3rd to 21st as 'Black September' as September 3rd, 2023 will mark four months since Kukis started the present conflict causing exodus of innocent Meitei people and dissolving of Manipur's own Constitution formed in 1947 and Assembly on September 21, 1949.

But, by his statements the said accused has in-fact propagated his own successionist agenda through the observance of Black September, thereby challenging the dissolution of Manipur's Constitution framed in the year 1947 and Assembly on September 21st, 1949. And, these are clear act of separatism which threatens the integrity of the Nation and mobilization of people for such activities is encouragement of secessionist activities from the Union of India. His said activities and statements amount to challenging the merger agreement dated 21st September, 1949 of Manipur State to the Union of India and vocalized thereby instigating innocent people for separation from the Union of India by openly waging war against the Union of India and the State of Manipur, with a clear attempt/intention to overthrow the governments duly established by law. His act also amounts to abetment for mutiny.

As such prevention of him from continuing such unlawful separatist / terrorist activities are of great public importance in view of the various hardships faced by the innocent people of Manipur at the hands of foreign based narco-terrorists.

In the narrated facts and circumstances, he is liable to be punished under Section 120-A, 120-B, 121, 121-A, 132 & 153-B of Indian Penal Code 1860 and Section 15, 16 and 18 of the Unlawful Activities (Prevention) Act, 1967 and strict legal action is to be taken under the relevant provisions of law.

Hence, a suo-motu case under FIR No. 735(9)2023 IPS u/s 120-A/120-B/121/121-A/132/153-B IPC & 15/16/18 UA(P)Act, 1967 has been registered against Phambei spokesperson Ningthouja Lancha and other members of Phambei organization for investigation.
