Dear Madam,

I, Thanglal Mate age about 48 years S/O Hemkhopao Mate a Permanent resident of L.Bethel Veng, Saikul Kangpokpi, Manipur belonging to a Mate Scheduled Tribe was working as a Security Guard at Christian Hospital Imphal Dulahland, P.O.&P.S. Imphal District Imphal East while staying at their mission quarters(Christian Hospital Campus).

That, due the communal violence in Manipur, I along with my family have fled toward Kangpokpi on the 7<sup>th</sup> Day of May 2023 for our own safety leaving behind all belonging at our quarter and that the said quarter was looted and vandalized by Meitei miscreant on the 3<sup>rd</sup> July 2023 at around 2:00pm. There by causing a loss estimated to be at a value of Rs.300,000/- (Rupees Three Lakhs only) including of Furniture and House hold Goods and my delayed in filing this report may be negate due to frequent shifting of places.

I therefore, would like to request your kind office to take necessary action at the earliest so that the culprit may be booked under the provision of law.
