

Subject:- Report on Crimes of vandalised and looting of properties , Discrimination of
Schedule Tribes

Respected Madam,

With reference to the above cited subject, I have the honour to report to your good office
as follows:

That, I, Paogoulen Haokip aged 41 years d/o (L) Mangtinlen Haokip belonging to the
Any Kuki tribe/community, a Schedule Tribe recognized under the Constitution of India, by
virtue of which I am being entitled to the protection under **The SC/ST (Prevention of
Atrocities) Act, 1989.**

That, I would like to inform and register a cognizable offence carried against my family
at our owned house located at Old Lambulane Jail Road, P.O & P.S- Imphal West, District-
Imphal West.

That, on the **4th of May, 2023** at around **9:30 PM**, a huge contingent of armed radical
Meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun attacked
our locality but fail to succeed yet fearing for our lives we fled from the said resident.

That, it may be reported here from a reliable source that our properties have been looted
from our deserted house by the meeitei/Meitei miscreant which have caused grave mental
agony and incurred huge loss which may be estimated (approx.) to be **Rs 14,40,000/-**
(Rupees Fourteen Lakh Forty thousand) only and also it may be mentioned that a parlour
named Api Beauty Parlour's room rented from the same locality bearing UDYAM No.
MN050012013 proprietor Lhaineivah Haokip w/o Paogoulen Haokip was also looted causing
a huge loss of Rs.10,00,000/- (Rupees Ten Lakh only)

Fortunately, I and my family managed to escaped from these criminals who even tried
to kill or burn us alive, and now currently taking refuge at Beulahlane P.O. & P.S.
Churachandpur, Dist. Churachandpur, Manipur.

I am filing this report lately since I have been at different places for safety. Now, since I
am able to settle myself at the above mentioned address, I am in a position to file a report
today. Hence, prayed that my report be accepted.

In the given circumstances, I humbly pray you to kindly register a **ZERO FIR**,
investigate the matter and punish the perpetrators as per the prevailing provisions of the laws
of the land. And, for which act of kindness, I shall always remain thankful to you and
obliged.
