Due to the ongoing ethnical violence on May 3, 2023 in Manipur, I have left my light vehicle behind in Imphal on May 6, 2023 as I had fled via flight from Imphal to Guwahati and Guwahati to Shillong by road, a two - wheeler Yamaha Cygnus Alpha White, registration number ML05M2462 and engine number - E3N7E0091784, chassis number - ME1SE7749E0091839 and Insurance policy number - 2320100910884802000 from HDFC ERGO insurance company with address F/No- 2B Second Floor, Gilgal Apartment, Dewlaland near Tiny Tots School, Imphal-1795001. On the 11th of August, 2023 I had contacted my friend from RBI Imphal office to check on my vehicle for me and he reported that it is has been missing or stolen by miscreants last month July 2023 as I could not pinpoint the exact date on when it was stolen.
