I have the honour to State that, on date 15/ 05/ 2023 at around 10: 00 Pm some unknown miscreants suspected to be a members of Meitei youth Organisation such as Meitei Leepun, Kangleipak kanba lup ( KKL), Arambai Tenggol and women wings , World meiteis Council (WMC), Schedule Tribes Demand committee (STDC), numbering about 1500 – 2000 persons carrying Sophisticated weapons like AK, SLR, INSAS and 303 rifles forcefully entered our colony.

Cannan veng Pastor Quarter (KBC) North AOC, Imphal East under Prompat Police station, After looting all the moveable properties vandalised our houses including, Steel Armerah, , Table, Benches, Sofa seat 2 NOS., Refegeratar, Disk top computer, Gas stove, Cylinder 3 nos, Kitchen Amirah, Bed nos, 4 seat, Gazer, Tv, Washing machines, Personal Dress for all the family members, The approximate value of properties destroyed estimate calculated at about Rs. 15, 00, 0000 ( Fifteen lakhs)

It is therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to Law.
