I have the honour to State that, on date 15/05/2023 at around 10:00 Pm some unknown miscreants suspected to be a members of Meitei youth Organisation such as Meitei Leepun, Kangleipak kanba lup (KKL), Arambai Tenggol and women wings, World meiteis Council (WMC), Schedule Tribes Demand committee (STDC), numbering about 1500 – 2000 persons carrying Sophisticated weapons like AK, SLR, INSAS and 303 rifles forcefully entered our colony.

Cannan veng via Zoumi villa North AOC, Imphal East under Prompat Police station, After looting all the moveable properties like, Steel Armerah, Yamaha Keyboard, Table, Benches, Sofa seat, Mixture, they vandalised our houses including Church and Church properties, Church office, Public Toilet including all the household properties to the ground leaving, The approximate value of properties destroyed estimate calculated at about Rs. 10 00,00, 000 (Ten cores)
