With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the *Any Kuki Tribe*, a recognized Scheduled Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**.

That, I am a student pursuing my masters under Dhanamanjuri University (D.M.U.) bearing **Roll No. 2151042** located at Imphal West, P.O.-DM College & P.S.- City Police Station and district- Imphal West-795001. Staying at Emmmanuel Girl's Hostel located at Dewlahland, P.O.-DM College & **P.S.- Imphal Police Station** and District- Imphal West-795001.

That, on the **4<sup>th</sup> of May, 2023** at around **11:00 AM**, I left from the said hostel to take refuge in 2<sup>nd</sup> Manipur Rifles (MR), after noticing that miscreant's mob belonging to the Meetei community suspected to be the members of Arambai Tenggol and Meetei Leepun unlawfully roam around Imphal City in search of persons belonging to the Kuki /Zo Tribes.

That, it may be mentioned here that my study materials along with my personal belongings which I deserted are still in my room and status of looting/vandalizing is still unconfirmed and no news thereafter. I would also like to add that, I have been facing difficulties in going to the Valley/ Imphal area to continue my studies.


