**Subject:** - Report on crimes of looting, vandalism, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes



Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I am a Scheduled Tribe belonging to the *Any Kuki Tribe*, a recognized Scheduled Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**.
2. That, I am a student pursuing my masters under Dhanamanjuri University (D.M.U.) bearing **Regn. No. 18520644** located at Imphal West, P.O.-DM College & P.S.- City Police Station and district- Imphal West-795001. Staying at KBC Working Women Hostel located at Dewlahland, P.O.-DM College & **P.S.- Imphal Police Station** and District- Imphal West-795001.
3. That, on the **4<sup>th</sup> of May, 2023** at around **11:45 AM**, I left from the said hostel to 2<sup>nd</sup> Manipur Rifles (MR), after noticing that miscreant's mob belonging to the Meetei community suspected to be the members of Arambai Tenggol and Meetei Leepun unlawfully entered the neighborhood in search of persons belonging to the Kuki /Zo Tribes. I would like to add that I have deserted my Two-Wheeler (Automatic Scooter), make and model is **Honda Dio, Black & White in Colour**, bearing **Regn. No. MN 02 B 3150**, registered under the name, Mangjakhup Haokip which estimated to be Rs. 60.000/- (Rupees Sixty Thousand) only.

4. That, it may be mentioned here that my study materials along with my personal belongings including my Two-Wheeler which I deserted are now looted and vandalized which is estimated to be worth about **Rs.2,15,000/- (Rupees Two Lakhs Fifteen Thousand) only**. I would also like to add that, I have been facing difficulties in going to the Valley/ Imphal area to continue my studies.

In the given circumstances, I humbly pray you to kindly register **a ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. And, thus I am filing the report lately today.
