

Subject: - First Information Report regarding intimidation and attack on Nursing Student namely- **Ms. Vungzouzam**, D/o Robert Z. Tythul, a resident of Tangpijol Village, P.O. & P.S.- Singngat, District- Churachandpur, Manipur.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I belong to the Zou Tribe, a recognized Scheduled Tribe under the Constitution of India. I am a student of College of Nursing under the Medical Directorate, Government of Manipur. And, I am a hosteller of the Nursing School at Lamphelpat, Imphal at Room No. 114.
2. That, due to the ethnic clashes between the majority Meitei community and the Kukis, our peaceful stay at the Nursing Hostel at Lamphelpat, Imphal could not be continued as the majority Meitei community, shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. (meaning- "Long Live Kangleipak"; "Kill the Kukis"; "Kill the Tribals") were checking Identity cards of students to identify who belongs to the Kuki community. And, those found to belong to the Kuki communities were subjected to assaults and abuses and some were even killed.
3. That, fortunately, with the support and help of our Naga and Meitei friends at the hostel, I managed to escaped from the above said miscreants. And, on the 4th of May, 2023 at about 2:00 PM, the army picked us up and dropped us at the 1st Manipur Rifles relief camp. And, from there we were evacuated to Churachandpur safely.

In the given circumstances, I humbly pray you to kindly register my case, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
