Subject: Circulation of news by Elite News on Social Media which can have repercussion on the law and order situation in the State - regarding

Sir,

"I am to invite a reference to letter No. IT/12/2023-DITC-DIT dated 6th September, 2023 received from the Director (IT), Government of Manipur (copy enclosed) on the above subject matter and to state that the department has reported circulation of certain contents by Elite TV News on Social Media which can have repercussions on the law and order situation in the State.

- The matter has also been taken up with the Ministry of Electronics and Information 2. Technology, Government of India with a request to block the Channel and take down the posts under Section 69A of the IT Act.
- That, since 3rd of May, 2023 in order to bring public tranquillity, protection of lives and 3. properties, prohibitory orders under Section 144 (1) of Cr.P.C. is being enforced viz. first on 3rd May, 2023, secondly on 3rd July, 2023 and latest on 2rd September, 2023 wherein any act or activities that could lead to furtherance of the unrest and the disturbance to the law and order can be prevented.
- It may also be highlighted here that under the existing law and order situation in the 4. state, which is slowly limping back to normalcy, the broadcasting/uploading of contents that are likely to disturb the public tranquillity is highly uncalled for.
- You are requested to register an FIR against the concerned and the said social media channel viz. Elite TV be restrained from circulation of content detrimental to the present law and order situation in the state which may incite further violence and hatred. Action taken report should be submitted at the earliest.
