With reference to the above cited subject, I have the honour to report to your good office as follows:

That, I Ms. Mawinu Haokip aged about 48 years W/o Thongsat Haokip belonging to the Any Kuki tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, I would like to inform and register a cognizable offence carried against me and my family at our rented house located at Zo mi Villa, North AOC, Imphal East District. P.S-

That, on the 4th of May, 2023 at around 9:30 AM, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tenggol and Meetei/ Meitei Leepun attacked our locality and has looted our house taking away all the properties of the deserted resident.

That, it may be reported here that above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated (approx.) to be Rs 11,65,600 /- (Rupees Eleven Lakh sixty-five thousand six hundred) only.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill us and now currently taking refuge at S.Munnuam Village, P.O. & P.S. Churachandpur, Dist. Churachandpur, Manipur.

I am filing this report lately since I have been at different places for safety. Now, since I am able to settle myself at the above mentioned address, I am in a position to file a report today. Hence, prayed that my report be accepted.

In the given circumstances, I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of the land. And, for which act of kindness, I shall always remain thankful to you and obliged.
