Subject - Report on / crimes of vandalism and looting of properties /  
- discrimination of Scheduled Tribes.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the ZOU Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our resident at KAMSUAN LIANZAW of KABO LEIKAM, DEWLAHLAND, P.O./P.S. Imphal PS, District- IMPHAL EAST on the 4<sup>th</sup> of MAY, 2023 at around 6.00 AM/PM, it has come to our knowledge that our deserted house was attacked, destroyed and looted by a Group of radical Meeitei/Meiteis suspected to be members of Arambai Tengol and Meitei Leepun on the 2<sup>nd</sup> of AUGUST, 2023 at around 4:00 AM/PM.

The criminals broke open my door, destroyed and looted every valuable property from my house/ premises worth about Rs. 108,00,000/- (one crore and Eight Lakhs ..... ) only.

That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE", "KUKI HATLO", "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because



everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

I, therefore, request you to kindly register my case as **ZERO FIR** and take stern action against the perpetrators under the relevant provisions of the law of our country.
