I along with my family left our resident at KAMSUAN LIANZAW READ LEIKHLAND DISTRICT IMPHAL CAST on the ALL of MAY., 2023 at around ... 6.00. AM/PM, it has come to our knowledge that our deserted house was attacked, destroyed and looted by a Group of radical Meeitei/Meiteis suspected to be members of Arambai Tengol and Meetei Leepun on the ALL of Augus 7 2023 at around A: DAM/PM.

That, it may be reported here that the miscreants were shouting slogans like-"KANGLEIPAK VAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because

everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

I, therefore, request you to kindly register my case as ZERO FIR and take stern action against the perpetrators under the relevant provisions of the law of our country.
