Subject - Report on crimes of attempt to murder, vandalism, looting of properties and discrimination of Scheduled Tribes.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the **Kuki Tribe**, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our rented house **owned by Smt. Abem (8414862440)** located at Dewlahland, P.O./P.S.-
District- Imphal East-795001 on the **4th of May, 2023** at around **8:30:00 AM** we escaped to the Chirstian Hosipal(Dewlahland) took refuge for a week, then by the help of Central Forces Jawans we were escorted to Kangpokpi Dist. and we had to cover up different places before reaching Churachandpur Dist. and it has come to our knowledge that our deserted residence was attacked and looted by a Group of radical Meitei/ Meiteis suspected to be members of Arambai Tengol and Meetei Leepun on **10th of June, 2023** at around **10:30AM** despite of my landlady trying to safe-guard our properties who also belongs to the Meitei/ Meiteis community herself, but she failed as she was threatened by the said miscreants, if she gives a helping-hand towards the Kuki tribals she would also receive the same treatment as the said Kuki victims.

That, the criminals broke open my door, destroyed and looted everything and the total evaluation of properties looted/ destroyed from my house/ premise is worth about **Rs.17,02,900/- (Rupees Seventeen Lakhs Two Thousand Nine Hundred)** only.


That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.




