That, the criminals broke open my door, destroyed and looted everything and the total evaluation of properties looted/ destroyed from my house/ premise is worth about Rs.17,02,900 /- (Rupees Seventeen Lakhs Two Thousand Nine Hundred) only.

That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
